

Young Men's Youth Survey Prize Draw – Terms and Conditions

1. Promoter

The promoter is Stride Mental Health Limited (ABN 58 000 020 146), the lead agency operating headspace Geelong ("Promoter").

2. Promotion Period

The headspace Geelong Youth Survey Prize Draw ("Promotion") opens on 04/06/2026 and closes at 11:59pm on 03/08/2026 ("Promotion Period").

Entries received after the Promotion Period will not be accepted.

3. Eligibility

- Entry is open to individuals who:
 - Are residents of Victoria, Australia;
 - Are aged between 12 and 25 years inclusive at the time of entry; and
 - Complete the survey during the Promotion Period.
- Participants under 18 years of age must have the consent of a parent or legal guardian to participate in the survey and enter the Promotion.
- Employees, contractors, volunteers, directors, and immediate family members of the Promoter who are directly involved in the administration of the Promotion are not eligible to enter.

4. Participation

- Participation in the survey and entry into the Promotion is entirely voluntary.
- Choosing not to participate in the survey, choosing not to enter the Promotion, or withdrawing from the survey will not affect a participant's ability to access any services, supports, programs, or opportunities provided by headspace Geelong or the Promoter.

5. How to Enter

- To enter the Promotion, eligible participants must complete the designated survey during the Promotion Period and separately submit their contact details via the prize draw entry form.
- Survey responses and prize draw entry details will be collected separately and will not be linked by the Promoter for the purpose of identifying individual survey responses.
- Only one (1) entry per person is permitted.
- No purchase or payment is required to enter.
- The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who submits an entry that is incomplete, misleading, fraudulent, duplicated, or otherwise not in accordance with these Terms and Conditions.

6. Prize Details

- Five (5) prizes are available.
- Each prize consists of one (1) Prezzy Digital Gift Card valued at AUD \$30 AUD.
- The total prize pool value is AUD \$150 AUD.
- Prizes are not transferable, exchangeable, refundable, or redeemable for cash.

- Any terms and conditions imposed by Prezzye apply to the use and redemption of the gift cards.

7. Winner Selection

- Winners will be selected by random draw from all eligible entries received during the Promotion Period.
- The draw will take place on 07/08/2026 at headspace Geelong or another location determined by the Promoter.
- Five (5) winners will be drawn.
- The Promoter's decision is final and no correspondence will be entered into regarding the outcome of the draw.

8. Notification of Winners

- Winners will be notified by email, telephone, or other contact details provided in the prize draw entry form within seven (7) days of the draw.
- Winners must respond and confirm acceptance of the prize within fourteen (14) days of being notified.
- If a winner is under 18 years of age, the Promoter may require confirmation of parental or guardian consent before awarding the prize.

9. Unclaimed Prizes

- If a winner cannot be contacted, does not respond within fourteen (14) days, declines the prize, or is found to be ineligible, the prize will be forfeited.
- The Promoter may conduct a redraw from the remaining eligible entries if necessary.
- Any redraw winner will be notified in the same manner as the original winner.

10. Privacy

- The Promoter collects personal information for the purposes of administering the survey, conducting the Promotion, contacting winners, and distributing prizes.
- Participation in the survey is voluntary.
- Survey responses may be used for service planning, evaluation, reporting, research, and quality improvement purposes. Where possible, results will be reported in aggregated and de-identified form.
- To help protect participant privacy and confidentiality, survey responses are collected separately from prize draw entry details.
- Contact information provided through the prize draw entry form is stored separately from survey responses and is used only for administering the Promotion and contacting winners.
- The Promoter will not use prize draw entry details to identify or attribute individual survey responses except where required by law.
- Personal information will be handled in accordance with applicable privacy laws and the Promoter's Privacy Policy.

11. Limitation of Liability

- To the extent permitted by law, the Promoter is not responsible for any late, lost, incomplete, corrupted, misdirected, or incorrectly submitted entries.

- The Promoter is not liable for any technical malfunction, communication failure, or other circumstance beyond its reasonable control that affects participation in the Promotion.
- Nothing in these Terms and Conditions excludes, restricts, or modifies any rights or remedies available under the Australian Consumer Law or any other applicable legislation that cannot lawfully be excluded.

12. Cancellation and Changes

The Promoter reserves the right to cancel, suspend, amend, or vary the Promotion where reasonably necessary due to circumstances beyond its control or where required to comply with applicable laws.

13. Governing Law

These Terms and Conditions are governed by the laws of Victoria, Australia. Participants submit to the non-exclusive jurisdiction of the courts of Victoria.

14. Acceptance of Terms

By participating in the survey and entering the Promotion, participants are deemed to have accepted these Terms and Conditions.
